The taxable values for Town, County and Village of Lancaster can be found in the right column of the individual property screen. Divide the taxable value by \$1,000, then multiply that value times the rate. Then you must use the total assessed value found in the left column divided by \$1,000 for Special District ad valorem charges.

The taxable value for School purposes does not include STAR savings. You must click on exemption in the upper right hand corner of the property screen. If the STAR exemption is on the property, you can deduct the exemption amount from the taxable amount, divide by \$1,000, then multiply that value times the tax rate for your school district to arrive at the net school tax amount for the property.

Actual tax amounts for a particular property can be found on the individual property screen in the upper right hand corner identified as "Tax Bill".
